**1983** Founding of first international subsidiary in Paris (KERN SARL, Traduction et Interprétation). Later branches opened in New York, London, Hong Kong, San Francisco, Amsterdam and Vienna.

**1985** KERN & PARTNER Marketing Agency takes over the development of foreign-language marketing material and multilingual desktop-publishing.

**1997** Transition of KERN to KERN Global Language Services. First company-wide use of translation- and terminology-management tools. Server-linked installations of Across and SDL henceforth used as standard workflow tools.

**2005** KERN acquires IKL Business Language Training and founds KERN IKL Business Language Training & Co. KG. Consolidation of their shared office- and teaching-space into present company headquarters at Kurfürstenstraße 1, Frankfurt am Main.

**2008** Launch of the KERN-developed, client-specific translation and terminology-management portal “clicktranslate” and „term4client”.

**2009** Certification of KERN IKL Business Language Training & Co. KG as a recognized workplace for advanced internships, according to TÜV Hessen (Technical Supervisory Board) Employment Accredita-

tion and Licensing Requirements, SGB III (Social Code III). The language exam “lingoscore” is developed for use by Human Resource Departments.

**2010** Market launch of the client-specific, browser-based translation management portal „portal4client”.

**2016** Expansion of the area of foreign language teaching in Austria by integrating the CEF Institute into KERN Austria GmbH.

**2018** Takeover of translingua KG in Austria and integration into KERN Austria GmbH.
